Regulations for the use of St. John UCC facilities:

- 3. Floor must be swept, spills wet-mopped (materials in utility room).
- 4. Bring your own paper or plastic goods (i.e., plates, cups, napkins, forks, spoons, etc.).
- 5. Garbage must be taken out and placed in the dumpster.
- 6. Kitchen and rest rooms should be clean.
- 7. All personal property must be removed, lights turned off, building securely locked, and key returned to church office during office hours.
- 8. Access to Fellowship Hall will be through the SE parking lot entrance only.
- 9. Building must be vacated by 10:30 p.m.
- 10. Member who requests the use of facilities or equipment will be held responsible for damages, thefts, or any other type of loss incurred.
- 11. Member must know the location of exits and fire extinguishers in the building.
- 12. St. John UCC is not liable for any injury or loss of any kind.
- 13. Consumption of beer and wine in Fellowship Hall or outside is permissible for church functions; i.e., church picnics, clean-up activities, tailgate parties at church, etc.
- 14. Consumption of beer and/or wine involving approved church member activities in Fellowship Hall requires approval of Church Council at the time application is made.
- 15. NO rice throwing. Birdseed may be used outside of building.
